The tasks and goals of the German Jazz Union e. V. are wide-ranging. The aim is to give "Jazz made in Germany" an appropriate social status within German and Europes diverse cultural scene.

Jazz in and from Germany is globally renowned and creates innovative potential in all areas of society. Public funding is just as essential for free scenes in jazz and improvised music as it is in institutionalized music and culture.

The German Jazz Union represents the interests of all jazz musicians in Germany and is particularly committed to the following goals:

1. SPECIFIC FUNDING FOR JAZZ AND IMPROVISED MUSIC Expansion of public funding, design of existing and new funding instruments at federal level. Jazz experts in relevant institutions. 2. VENUES Expansion of public funding for jazz and improvised music venues, creation of fully financed jazz centers. Stronger support from the federal states and local authorities. 3. FAIR COMPENSATION AND SOCIAL SECURITY Ensuring appropriate compensation. Short term minimum and long term fair fees for musicians, strengthening of social security, in particular through the expansion of the German Social Fund for Artists (Künstlersozialkasse). 4. EDUCATION AND TEACHING Jazz and improvised music as an integral part of school curricula, reduction of unstable working conditions in teaching. 5. INTEREST GROUPS AND NETWORKS Strengthening of interest groups and network structures by stronger representation of the interests of all jazz musicians. 6. JAZZ IN THE MEDIA Stronger presence of jazz in all media; appropriate broadcasting slots, contemporary and exciting concepts and programs in public broadcasting. 7. EXPORT PROMOTION Presentation of jazz from Germany on a global scale, effective and unbureaucratic export promotion programs.

THE GERMAN JA77 UNION: PROMOTING JA77 SINCE 1973.

For more than 45 years, the German Jazz Union has been representing the interests of jazz musicians in Germany towards legislative and political bodies, as well as institutions promoting culture at a federal level. After restructuring in 2012, the German Jazz Union has established itself as a professional association and, with currently around 1,2000 members, it has become an important cultural-political body.

Since the publication of the Jazz Study 2016, considerable milestones regarding the living and working conditions for jazz musicians in Germany have been achieved. Some of these measures include the establishment of the German Music Fund (Musikfonds) as the federal fund for contemporary music with the participation of the German Jazz Union as well as the increase in federal funding for the APPLAUS Award for the programmes of music venues.

In close cooperation with the Federal Conference on Jazz (BK-Jazz) as well as other jazz-related institutions and institutions on the federal and regional level, we are committed to promoting the most pressing professional and cultural-political topics. The increase in social and political awareness shows that we are heading in the right direction. The German Jazz Union is represented in national and international committees and organizations. In addition to the Federal Conference on Jazz (BKJazz) and the German Music Fund (Musikfonds), these include the German Cultural Council (Deutscher Kulturrat), the German Music Council (Deutsche Musikrat), the Cultural-Political Society (Kulturpolitische Gesellschaft), the Alliance of Liberal Arts (Allianz der freien Künste) and the German Social Fund for Artists (Künstlersozialkasse).

The German Jazz Union sends experts to juries such as APPLAUS, Initiative Musik, the German Award for Jazz Journalism (Preis für Deutschen Jazzjournalismus), the SWR Jazz Award (SWR-Jazzpreis) and the German Festival for Young Jazz Musicians (Jugend jazzt).
