### What we've already achieved

### We advocate for jazz

Over the past years, we've established ourselves as the largest genre-specific association for musicians in Germany and have become a nationwide voice for jazz and improvised music.

### Targeted funding

With the Albert Mangelsdorff Prize, we created the most prestigious jazz award in the Germanspeaking world. We also co-developed important funding programs and structures such as MUSIKFONDS, APPLAUS, and the German Jazz Prize, all of which support jazz and improvised music and help increase their visibility.

### **Establishing minimum fee recommendations**

We played a key role in the collaborative process of establishing minimum fee recommendations, which are reviewed and updated annually. We ensure that the perspective of jazz musicians is always part of this process.

# Driving transformation through research and reporting

Our studies and publications enhance understanding of the living and working conditions of jazz musicians in Germany. We also actively address and combat gender-based discrimination in the scene.

### **Education & networking**

Through initiatives like Jazzpilot\*innen, we've been promoting political education and democracy for years. Our Jazz Now! forum is recognized as a forward-thinking space for discourse and addresses social and cultural policy developments every two years.
